- You can also apply directly online, using the Saits system https://saits-vaxjo.ist.se/vaxjo/login.htm
- Note: Only one child per application form.
- In the case of municipal placement, the application should be submitted at least six months before the desired placement date. You can only credit a maximum of six months' waiting time.
- Data necessary for queuing and fee debiting will be placed in a database as long as they are current and processed in accordance with the provisions of the Personal Data Act (PUL).
- If you want a place at an independent preschool/afterschool care, you must submit the application to Växjö kommun, utbildningsförvaltningen.

Information on queuing and similar matters concerning independent activities can be obtained by contacting the respective independent preschool/educational care/after-school care.
